The undersigned is directed to refer to your communication no. GSECL/UTN.EXTN/703/271 dated 18.11. 2006 regarding the subject mentioned above. Subsequent information furnished vide letter dt. 6.12.2008 and State Level Expert Appraisal Committee (SEAC), Gujarat letter no. EIA-10-200-249-E dt. 24.9.2008 have also been considered.

2. It is noted that the environmental clearance for the expansion project of 330 MW was accorded by Department of Forests & Environment, Govt. of Gujarat vide letter no. ENV-10.2004-120-P dated 3<sup>rd</sup> June, 2005. M/s GSECL has now proposed for enhancement in capacity from 330 MW to 374.57 MW.

3. The proposal has been considered and in accordance with the recommendation of the EAC, the Ministry of Environment & Forests hereby grants environmental clearance to the enhancement of capacity from 330 MW to 374.57 MW of the above mentioned project subject to implementation of the following additional conditions.

- (i) The stack height shall not be less than 30 m.
- (ii) The NOx emissions shall be limited to 50 ppm.
- (iii) Project Proponent will upload the compliance status of the stipulated conditions in their website and update the same every six monthly.
