

## **Instruction - Question Paper/Answer Key of Exam dated 18.02.2018**

- Stream wise Question Paper along with Answer Key will be available on our website: [www.gsecl.in](http://www.gsecl.in) from dtd.20.02.2018 to 24.02.2018 (**timing will be displayed later on**), for which the candidate has to login from his/her login ID.
- If any candidate has any suggestion, he/she may proceed as per the steps shown in the link (from his/her login ID) and no suggestion will be considered or entertained after 24.02.2018.
- After taking the decision on the suggestion received, provisional result (i.e. the marks acquired by the candidates) will be published on dtd. 28.02.2018 on our website.
- The minimum eligibility cut off marks for selection will be 50 and above marks for unreserved candidates and 45 and above for reserved candidates. **(As per GSO-3)**
- On the basis of merit and reservation norms, the eligible candidates will be called for documents verification and pre-medical examination tentatively in 2<sup>nd</sup> week of March, 2018. If the candidate does not remain present on the specified date, it shall be presumed that the candidate is not interested and his/her name shall be deleted from the provisional list. **The date will be intimated to each candidate on his registered mail.**
- Candidates shall have to bring the admit card whenever they are called for documents verification.
- Mere appearance of name in the provisional list does not confer any rights and the actual appointment will depend upon the availability of vacancies and reservation rules.
- The Final selection list would consist of those candidates who have been found meeting with the criteria after documents verification, medical examination etc.
- While preparing final selection list, if any candidate found with equal marks, they will be kept in merit according to their date of birth i.e. elder will be kept in priority to younger and if the date of birth is also found same, then they will be kept in priority according to alphabet seniority of name.
- The candidates who have applied under GSO-295 (dependents of retired/expired employees of GUVNL and its subsidiaries) and candidates who have completed apprenticeship under BOAT (Board of Apprenticeship Training)

scheme from GSECL will be given preference over other candidates who acquired equal marks. In case of equal marks, between GSO-295 and BOAT, then GSO-295 candidates shall be given preference over BOAT candidate.

- The validity of provisional list will be for one year from the date of publication.
- The candidates selected to the post of VS (JE) shall have to join at their place of posting within stipulated time shown in appointment letter. No extension will be granted as they have to undergo the Induction Training for a period of 10 weeks.
- In case of Instrument Mechanic, after documents verification and medical examination their names shall be allotted to Power Stations and Chief Engineer shall issue appointment letters.
- Only those candidates who submit the caste certificate issued by authorities of Govt. of Gujarat will be considered against reserved posts.
- Minimum 85% of representation in selection will be of local resident of Gujarat as per GR dtd.31.03.95. The candidate shall have to submit the Domicile Certificate of being resident of Gujarat State if he/she claims appointment under 85% quota. **(The candidates of Gujarat State are advised to get ready the domicile certificate issued by the Competent Authority of Gujarat State at time documents verification.)**
- **The candidates belonging to SEBC category are advised to get ready the Caste Certificate and latest Non-Creamy layer Certificate in Gujarati – પરિશિષ્ટ – ૬ or પરિશિષ્ટ – ૪ (ગુજરાતી) issued by the Competent Authority of Gujarat State at the time of documents verification.**

The candidates are advised to visit website regularly for updates.
